Biosecurity experts support Disbrow

Confidence in the newly announced BARDA director is high among biosecurity industry

WASHINGTON, DC – Dr. Gary Disbrow, PhD, has been named Deputy Assistant Secretary for Preparedness & Response and Director of the Biomedical Advanced Research & Development Authority (BARDA).

The Alliance for Biosecurity, the nation's leading coalition of medical countermeasure (MCM) developers, released the following statement regarding the announcement:

"BARDA, through partnerships with private industry, is an integral part of America's pandemic response and we have Dr. Gary Disbrow and the BARDA staff to thank for so much of the progress to date in developing diagnostics, therapeutics and vaccines to combat COVID-19 and future CBRN threats.

BARDA, a component of the Office of the Assistant Secretary for Preparedness and Response within the U.S. Department of Health and Human Services, invests in the innovation, advanced research and development, acquisition, and manufacturing of medical countermeasures – vaccines, drugs, therapeutics, diagnostic tools, and non-pharmaceutical products – needed to combat 21st century health security threats.

BARDA also established the Centers for Innovation in Advanced Development

and Manufacturing (CIADM) for the rapid, domestic manufacturing of MCMs needed to respond to pandemics and other public health emergencies.

Dr. Disbrow has previously served as:

- Acting BARDA Director and Deputy Assistant Secretary for Preparedness and Response,
- Deputy Assistant Secretary for Preparedness and Response – BARDA Medical Countermeasures Program Director,
- Director/Acting Director – BARDA Chemical, Biological, Radiological and Nuclear (CBRN) Division, and
- Deputy Director - BARDA CBRN Division.
